Introduction

1. This statement has been adopted by the Board of Cambrian Learning Trust (CLT) for use in its schools and the central team.
2. This statement applies to all shortlisted potential employees, employees working in schools and the central team. It also applies to all members of local governing bodies and the Board.
3. Further advice and support on the application of the policy is available from the HR Department.

Statement on Recruiting Applicants with Criminal Records

Contribution that people with criminal records can make

4. We recognise the contribution that people with criminal records can make as employees and volunteers and welcome applications from them. A person's criminal record will not, in itself, debar that person from being appointed to this post. Any information given will be treated in the strictest confidence. Suitable applicants will not be refused posts because of offences which are not relevant to, and do not place them at ,or make them a risk in, the role for which they are applying.

Consideration of conviction

5. All cases will be examined on an individual basis and the Trust will take the following into consideration:
 - Whether the conviction is relevant to the position applied for;
 - The seriousness of any offence revealed;
 - Your age at the time of the offence(s);
 - The length of time since the offence(s) occurred;
 - Whether the applicant has a pattern of offending behaviour;
 - The circumstances surrounding the offence(s), and the explanation(s) provided; and
 - Whether your circumstances have changed since the offending behaviour.

Regulated Activity

6. It is a legal requirement that all registered bodies and prospective employers must treat DBS applicants who have a criminal record fairly and not discriminate because of a conviction or other information revealed.
7. Employers who are Regulated Activity Providers (including Trusts and schools) are obliged to have a written policy on the recruitment of ex-offenders, which is available to DBS applicants at the outset of the recruitment process.
8. As an organisation using the Disclosure and Barring Service (DBS) checking service to assess applicants' suitability for positions of trust, (the Trust) complies fully with the Code of Practice and undertakes to treat all applicants for positions fairly. We undertake not to discriminate unfairly against any subject of a DBS check on the basis of a conviction or other information revealed.

Equality

9. The Trust is committed to the fair treatment of its employees, potential employees or users of its services, regardless of gender, pregnancy and maternity, ethnicity, culture, age, disability, sexual orientation, gender identity, religion or belief, marital and civil partnership status, education, learning styles, caring responsibilities or offending background.
10. This policy on the recruitment of ex-offenders is available on the [Trust Website](#) and is also available to all DBS applicants on request.
11. As a Trust we actively promote equality of opportunity for all with the right mix of talent, skills and potential and welcome applications from a wide range of candidates, including those with criminal records. We select all candidates for interview based on their skills, knowledge and experience.

DBS Checks and Criminal History

12. As a Regulated Activity Provider (RAP) most paid employees of the Trust are in regulated activity with children and therefore subject to checks of the DBS children's barred list in addition to enhanced DBS certificate.
13. In relation to volunteers and contractors, we only request a DBS check after a risk assessment had indicated that one is both proportionate and relevant to the position concerned.

14. For those positions where a DBS check is required, all job adverts will contain a statement that a DBS check will be requested in the event of the individual being offered the position.
15. We expect all applicants to provide details of any criminal record history that is not protected as defined by the Rehabilitation of Offenders Act 1974 (Exceptions) order 1975 (as amended in 2013) at an early stage in the application process, when they are notified that they have been shortlisted. Using the **Criminal record declaration form (exempt positions)** they should disclose details of any unspent convictions, cautions, reprimands, bindovers and final warnings they may have in addition to any pending criminal proceedings.
16. They should not disclose any criminal history that would be protected or filtered
17. We guarantee that this information will only be seen by those who need to see it as part of the recruitment process.
18. We ensure that everyone within the Trust who is involved in the recruitment process has been suitably briefed to identify and assess the relevance and circumstances of offences. We also ensure that they have received appropriate guidance on the relevant legislation relating to the employment of ex-offenders, e.g. the Rehabilitation of Offenders Act 1974 and its amendments and know how to access advice and support.
19. At interview, or on a separate occasion, we ensure that an open and measured discussion takes place on the subject of any relevant offences or other matter that may be relevant to the position.
20. Any offer of employment will be conditional on checks detailed in KCSIE, whether an outcome of a check is satisfactory will be determined by Cambrian Learning Trust.
21. We undertake to discuss any matter revealed in a DBS check with the person seeking the position before considering withdrawing a conditional offer of employment. This discussion and any subsequent risk assessment may be undertaken by our HR Manager or another trained member of our Senior Leadership Team.
22. Failure to reveal information that is directly relevant to the position sought could lead to the withdrawal of the conditional offer of employment if a candidate is appointed and has deliberately attempted to conceal the information requested in this form. It is important that applicants understand this could result in disciplinary proceedings or dismissal.
23. Further advice and guidance on disclosing criminal records can be obtained from Nacro's Criminal Record Support Service.

Criminal Record Declaration Form (Exempt Positions)

24. As part of our duty to safeguard pupils, we need to check whether you are barred from working with children, or whether you have convictions that would make you unsuitable to work with children or in the role you've applied for.
25. Please complete the following form as accurately as possible.
26. Note: you are not required to disclose convictions or cautions that are 'protected', as defined by the Rehabilitation of Offenders Act 1974 (Exceptions) Order 1975 (as amended in 2013). If you're not sure whether one of your convictions is 'protected', you can check here.
27. If you accidentally provide information about 'protected' convictions or cautions, we won't take this into account.

How we will use this information

28. We'll use the information in this form to:
- Identify whether you may be ineligible for a role based on barring, a section 128 direction or childcare disqualification requirements
 - Inform our conversations with you about any relevant details during the interview process
29. We won't use this information to make decisions about job offers.
30. If we offer you a position, we'll compare the information you've provided in this self-declaration with the information in your formal DBS check so that we only make decisions based on the most accurate information possible.
